#### 1. Public Health Preventive Measure

- The broadcast venue of the 62<sup>nd</sup> AGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the Meeting to be present at the main venue. **No members/proxy(ies) will be allowed to be physically present at the broadcast venue**.
- We **strongly encourage** you to attend the 62<sup>nd</sup> AGM using the RPV facilities. You may consider appointing the Chairman of the Meeting as your proxy to attend and vote on your behalf at the 62<sup>nd</sup> AGM.

#### 2. Entitlement to Participate and Vote using RPV facilities

- Only members whose names appear in the Record of Depositors as at 5.00 p.m. on 21 April 2023 (General Meeting Record of Depositors) shall be entitled to attend, speak (in the form of real time submission of typed texts) and vote at the 62<sup>nd</sup> AGM in respect of the number of shares registered in their name at that time.
- If a member wish to participate in the 62<sup>nd</sup> AGM via the RPV facilities, please **do not** submit any proxy form. You will not be allowed to participate in the 62<sup>nd</sup> AGM together with a proxy appointed by you.
- Members/proxies/corporate representatives/attorneys who wish to participate in the 62<sup>nd</sup> AGM remotely using the RPV facilities, please do read and follow the procedures in **Appendix A**.

As the  $62^{nd}$  AGM is a virtual AGM, members who are unable to participate in the  $62^{nd}$  AGM may appoint the Chairman of the Meeting as his/her proxy and indicate the voting instructions in the proxy form.

## 3. Appointment of Proxy(ies) or Corporate Representative(s) or Attorney(s)

- If a member is unable to attend the 62<sup>nd</sup> AGM via RPV facilities, he/she can appoint the Chairman of the Meeting as his or her proxy and indicate the voting instruction in the proxy form. - Members can proceed to vote on the resolutions at any time from the commencement of the 62<sup>nd</sup> AGM at 9.30 a.m. via RPV facilities and complete voting before the end of the voting session, which will be announced by the Chairman of the Meeting.
